

Dear Parents/Carers,

The inspector felt we had 'responded swiftly to address the findings of the previous inspection. No time has been wasted' and that 'the leadership arrangements are having a positive impact and we are an ambitious leadership team. Improvement planning is thorough. We have the backing of the staff.'

For us, this gives us the perfect springboard to continue to drive our schools further forward. As a team, we feel extremely passionate about our Federation and know we have an incredible team all wanting the very best for our children and families.

Now that we have settled back into school, I would like to take this opportunity to thank you for supporting the current high levels of attendance in all three schools.

The DfE guidance identifies that pupils needs to attend school regularly to benefit from their education. Missing out on lessons leaves children vulnerable to falling behind. Children with poor attendance tend to achieve less and therefore as a school we are expected to promote good attendance and reduce absence, including persistent absence (where a child's absence falls below 90%).

We wanted to remind you about a few processes in place to ensure that we can effectively track attendance and support families as needed.

- All holiday requests must be sent to <u>admin@spiresfederation.co.uk</u> for the attention of myself. These requests must be sent at least a week before the absence. All holidays will be unauthorised, unless it is deemed to be an exceptional circumstance.
- If unauthorised holiday absences total over 4.5 days in a 6 week rolling period, families can be liable for a Fixed Penalty Notice from LCC.
- All medical appointments, should where possible, be made out of school hours. If this is not possible, then please complete the Medical appointment request form. This can be found on our website or a paper can be sent home via the office.
- We have noticed an increase in the number of families arriving late after the school gates close. Pupils who arrive late have an unsettled start to the day and this can disrupt their learning, as well as that of their peers. In addition, punctuality is a key life skill that we are keen to promote.


Attendance Update Continued


• With unplanned absence, such as when your child is unwell, please ensure that you notify us as soon as possible by telephoning the school office and leaving a message on the answer machine (Option 1). If your child's absence goes beyond one day, we must be contacted on each subsequent day of absence. If you are unsure if your child should stay off school, please speak to the school office or consult the new DfE Is my child too ill for school? website


